RIBA Education Statistics 2018/19

The RIBA Education Department conducts an annual survey of schools of architecture; this data establishes key facts about architectural education in the UK. Collection of accurate data is essential for any professional organisation; this survey allows the RIBA to understand trends in this sector, and forms the basis for responses to government, media, and other bodies. This document describes the results of the survey for 2018-19, comparing results with figures for the last five years.

We would like to thank all heads of architecture and departmental administrators for responding so positively to this year's survey, and for providing all the detailed information we require. We are pleased to report that, with one understandable exception, all UK RIBA validated schools participated in this year's survey.

We have become used to seeing student numbers expanding year by year. This year's rise in the number of new entrants to Part 1 courses is the largest rise ever recorded, increasing entrants by more than 10 per cent. Another all-time high is the number of students from outside the UK entering Part 2. At both Parts 1 and 2, the number of EU students new to the course has increased.

The number of female students at all levels of study continues to rise, this year 53 per cent of applicants and 52 per cent of new entrants to Part 1 are female. We are starting to see a widening of ethnic diversity, with the number of students who are not white gradually rising in the last five years at all levels of study.

The first Apprentices are appearing in the statistics; 12 entered Part 1 courses and 23 Part 2. In the 2018/19 statistics, one School received apprentice new entrants at Part 1 and three Schools for Part 2. Clearly this new form of study is in its infancy and we will continue to monitor to see how it impacts student numbers in the coming years.

This year's survey has built on the initial analysis of geographic flow to include students at both Part 1 and Part 2. There seems to be less mobility in some regions compared with others, while students are more likely to remain in the same region between Part 1 and Part 2.

Finally, this foreword is being written against the background of a global health crisis, and with the UK completing the transition period to finally leave the EU on the last day of 2020. Both these events are likely to impact on the next years of this survey - although in ways we cannot yet predict.

Geographic movement of students

A new question about the geographic mobility of Part 1 new entrants was introduced into last year's survey, this has been extended to include Part 2 new entrants this year. The majority of students who live in the North, South West, Wales, Northern Ireland and Scotland study for Part 1 in the same geographic region as their home. A majority of students who are in these regions at the end of Part 1, together with students living in London, then continue to remain in the same region to study for Part 2.

Part 2 students are more likely to study very locally (within 5 miles of their home) than Part 1 students. But they are also more likely to study further away (over 150 miles) than Part 1 students. Figure 1: Average distance between home and School, new entrants to Part 1, 2018/19

Applications

More than 24,000 applications were received by Schools of Architecture for courses commencing in October 2018. This is the equivalent of 5.6 applications per place filled. The number of applications is higher than the previous year but lower than the year before.

Entry qualifications

More than half (56 per cent) of new entrants entered with A-Levels, Scottish Highers or International Baccalaureate. These remain the most popular entry qualifications. Level 3 qualifications (including vocational 16-19) were the next most popular type of entry, accounting for 23 per cent of new entrants. Three per cent entered with Level 4 or 5 and 2 per cent of new entrants were mature candidates. Six per cent entered with an overseas qualification.

New entrants to Part 1

The number of students entering RIBA validated Part 1 architecture courses has increased by 11 per cent compared with the previous year. Numbers have been rising consistently for a long period, but the 2018/19 rise is larger than ever before. A total of 4,420 students entered in 2018/19.

The proportion of female students on validated courses is 52 per cent, this proportion continues to rise and is 1 percentage point higher than the previous year.

The number of direct new entrants to the second year of Part 1 validated courses is 401.

Excluding where ethnic origin was not known or not recorded, the UK student intake at the 42 Schools able to provide information is 62 per cent white. Fourteen per cent are Asian or Asian British, 7 per cent black or black British, 7 per cent are mixed or multiple ethnic groups. Another 10 per cent are from other ethnic backgrounds.

While the *proportion* of students entering Part 1 from outside the UK remains at around one third, the *number* of new entrants from outside the UK continues to increase. The 2018/19 figure of 1,431 is the highest ever recorded.

Most of this increase is accounted for by many more students coming from the EU, whose numbers are 24 per cent higher than in the previous year. The number of students from elsewhere, in particular Asia, is almost identical to the previous year's figure.

New entrants to Part 2

The number of students entering RIBA validated Part 2 courses in 2018/19 is 2,302. This is 6 per cent higher than the previous year, one of the fastest rates of increase ever recorded. The proportion of new entrants to Part 2 who are female is 47 per cent, 2 percentage points higher than the figure recorded in the previous year.

A significant majority (73 per cent) of students who enter Part 2 have a UK first degree; another 6 per cent have a UK second degree. Four per cent enter with a European degree while 10 per cent have a qualification from outside Europe.

Excluding new entrants whose ethnic origin is not known, at Part 2 the UK student intake is 71 per cent white; 12 per cent are Asian or Asian British; and 6 per cent black or black British. Six per cent are of mixed or multiple origin and a further 6 per cent are from an other ethnic background.

There has been a substantial increase of 22 percent in the number of new entrants to Part 2 courses from outside the UK. This rise has also led to a rise in the proportion of students from outside the UK, which has increased from 34 per cent in 2017/18 to 39 per cent.

There are more students entering Part 2 from both the EU and from the rest of the world; both numbers are the highest recorded.

Students of all academic years

About 16,400 students are studying architecture at Part 1 and Part 2 (validated courses). This is a very similar number to the previous year, in spite of the rising number of new entrants measured at both Parts 1 and 2. About 4 per cent of students are undertaking part-time courses, similar to the previous year.

Examination results

These figures refer to examinations taken during the academic year 2017/18. A total of 1,499 students passed Part 3 exams in 2017/18. The long-term rising trend continues, the 2017/18 figure is almost 100 higher than the previous year's result. Indeed, numbers passing examinations are higher than the previous year for all stages. The number passing Part 1 is the highest in four years while the number passing Parts 2 and 3 are the highest on record.

Examination pass rates were 91 per cent at Part 1, 95 per cent at Part 2, and 87 per cent at Part 3.

Progression of female students

In this comparison of cohorts of students over time we assume that students take Part 1 finals in Year 3, Part 2 finals in Year 6 and Part 3 finals in Year 7 of their seven year education.

Historically the figures suggest a female drop-out rate of about 2 to 3 percentage points between Parts 1 and 2, and another 2 to 3 percentage points between Parts 2 and 3. The relationship between the proportion of female students applying and entering Part 1 is very close in most years. The figures show that there has been a long-term rise in the proportion of female students at all stages. Female students now out-number male students amongst applicants and new entrants to Part 1. The proportion of female students has increased markedly amongst students entering Part 2, where 47 per cent are female. And amongst students passing Part 3, the proportion of female students has increased to 43 per cent, having been below 40 per cent in all but one of the previous years.

Ethnic group of students

This analysis excludes students whose ethnic group is not known and is not provided by all Schools. The proportion of new entrants to Part 1 who are white is 62 per cent and the proportion of white students then rises with each consecutive stage; 71% of new entrants to Part 2 are white, as are 85% of students passing their Part 3 examination.

The information has been analysed to track cohorts of students. The analysis suggests the proportion of students who are white has decreased over time, at Part 1 and Part 2. This decrease has been most significant in the last five years. The proportion of students passing Part 3 who are white has changed at a slower pace. Definitions: White - British, Irish or any other White background.

Black or Black British including Caribbean, African or any other black background. Asian or Asian British - Indian, Pakistani, Bangladeshi or any other Asian background. Mixed or Multiple - White and Black African, White and Black Caribbean, White and Asian or any other mixed background. Other - Chinese or any other ethnic group.

Staffing

1,843 staff are employed in the validated Schools of Architecture. This is the full-time equivalent figure (FTE). Almost three quarters of these are teaching staff. Compared with last year the number of fulltime teaching staff is higher but the numbers of part-time teaching and support staff are lower. The total number of staff employed remains higher than in all but one of the previous years.

Averaged across all Schools, the student to teaching staff ratio is 11.7, a figure which has remained stable for the past three years.

Disability

Ten per cent of students have disclosed a disability. This is a slightly higher proportion than recorded in previous years. The largest source of disability remains a learning impairment.

The number of students who have disclosed a disability has increased long-term, the rate of increase is higher in 2018/19. Learning impairment remains the most significant disclosed disability, and there are now more students with multiple disabilities than in previous years.

Mental Health

About 2 per cent of students have a disclosed mental health issue. The total number of students with a disclosed mental health issue has increased by 51 per cent since the previous year and more than tripled over five years.
